BINDING TERMS AND CONDITIONS

- 1) The organizer of the fair is the Těžební unie s.r.o., below as the organizer, the event organizer, or the exhibition organizer.
- 2) The contract between the exhibitor and the exhibition organizer is accepted by confirming the REGISTRATION FORM FOR BINDING PARTICIPATION. On the exhibition organizer's website www.expolesnilom.cz, the exhibitor orders additional services, unless otherwise specified in a contract. Any legally based contractual relationship between the organizer and the exhibitor follow Czech legislation with the terms of the Commercial Code (Nový občanský zákoník č. 89/2012 Sb.). Confirming the REGISTRATION FORM is a necessary condition for confirming the order of EXPO stands and other services. The exhibitor is aware of all obligations related to his participation, the participation of his co-exhibitors and authorized representatives resulting from registration, order of stands and other services, or the transportation of exhibits.
- 3) The organizer of the exhibition decides on the final location of the exhibitors and size of ground area. In case of necessary technical reasons, the exhibition area can be made smaller or larger. Following the change in the size of the exhibition area, the amount of rent will be reduced or increased. The exhibitor will be informed about this fact in advance and accepts it. The organizer of the fair will try to respect the requirement of the chosen ground area and the ordered size.
- **4)** A guarantee of the exhibition area will be provided by the exhibition organizer after payment of the rental of the ordered ground area and the registration fee.
- 5) In the case of a delay in payment of the rent and the price of the ordered EXPO stands, equipment and services, the organizer is obliged to demand the payment of a sanction in the amount of 0.2% of the owed amount for each day. The right to compensation remains unaffected.
- **6)** The price of the exhibition ground area, for which the rent is paid, is specified in the Registration Form for Binding Participation. Each m² segment is counted as a whole.
- 7) If the exhibitor cancels the participation, the paid registration fee will not be refunded. If the exhibitor cancels the participation after the deadline specified in the "General Information", the price of the ordered area, stand, equipment and services is not refunded.
- 8) The exhibitor is not allowed to leave the exhibition area to third parties without the consent of the exhibition organizer.
- **9)** The exhibition area is given for use to the exhibitors or their authorized responsible persons only on the basis of confirmed payments, which should be in agreement with paragraph 4 of these terms and conditions.
- **10)** Exhibition area means the total ground area used for exhibits, their safe demonstration, EXPO stand, a warehouse of material for demonstrating machines and equipment.
- 11) The official partner for building the exhibition is the organizer. When arranging these works by another subject, the exhibitor is responsible for meeting all deadlines according to the time schedule specified in the "General Information" or closer time dispositions of the organizer
- 12) The exhibitors must comply with all safety, environmental and fire regulations for the construction of stands, weighing, assembly, disassembly and removal of exhibits, display of exhibits and movement of people and machines. They must ensure the safe operation of demonstration machines and equipment. They must ensure that they do not move or stand outside the designated area and do not endanger people and equipment. The machines are shown only in the designated area

- As the fair takes place in a quarry, safety instructions must be followed. Be careful especially when walking in the open areas. Not to enter the area through the barrier or the red safety tape. Follow the instructions of the organizing service. Follow the safety rules and prohibitions related to fire safety.
- **13)** During the practical demonstration of exhibits, in addition to the basic safety, ecological and fire regulations, the exhibitor must ensure that he does not unnecessarily disturb his surroundings with excessive noise, vibrations or dust. The given time for the demonstration must be respected. The organizer can limit or prohibit the demonstration of machines in operation.
- **14)** The exhibitors promote their products only within his own exhibition. Acoustic advertising, as well as placement of advertising banners outside the area, is subject to approval by the exhibition organizer.
- **15)** The exhibitor and co-exhibitors have the right to free publication in the exhibition Catalogue in the list of exhibitors. Another form of publication is done for a fee.
- **16)** The exhibition organizer is not responsible for damage or loss of exhibits, stand equipment and furnishings, goods and packaging material, regardless of when any loss or damage occurs. Before, during or after the fair. The exhibitor is insured for this purpose. The organizer of the exhibition will provide only basic security of the exhibition for the period specified in the schedule but is not responsible for damages caused by the exhibitor according to the first sentence of this paragraph.
- 17) The exhibitor is responsible for all exhibition areas, stands and equipment and is obliged to return them undamaged after the end of the event. For damage to the exhibition area, stand and equipment, the exhibitor is obliged to restore the exhibition to its original condition or pay the costs of the repair.
- 18) The exhibitor cannot remove the stand, the exposition or take away the exhibits before the end of the fair.
- 19) In the case that the exhibition organizer is unable to start the exhibition or other related event, ensure the event takes place or ensure traffic in a part of the exhibition centre due to circumstances beyond its fault ("force majeure"), the exhibitor will be informed immediately. All organizer's obligations from the exhibitor's participation contract cease. In this case, the exhibitor will not be compensated. If the exhibition is not possible after 1 April 2023 inclusive, right to compensation and refund ceases.
- **20)** Complaints must be made without undue delay. Otherwise, the right to compensation ceases.

ADMINISTRATIVE REGISTRATION AND INVOICES

If the exhibitor requires an area bordering on specific companies, or not bordering, he shall state this fact during registration. The organizer of the fair will try to comply with the request. The organizer of the exhibition decides on the final location of the exhibitors in the fair area.

SAFETY INSTRUCTIONS

For your own safety during the fair, the following rules must be respected without objections:

- Wear a safety helmet at exhibition grounds and in open areas, especially in places where machines and equipment will be demonstrated live.
- Walk only in the designated area.
- Do not enter the area through a barrier or red safety tape.
- Be extra careful when walking in open areas. You are moving in a guarry environment.
- · Do not come near to the upper or lower edge of the quarry walls.
- · Do not step on or touch the laid cable lines.
- Only qualified person can operate the exhibits shown in the demonstration.
- Person who operates the exhibits must not be drunk or drunk or under the influence of drugs.
- When showing exhibits to visitors, make sure that they are not injured or otherwise harmed.
- In case of injury, immediately ask for help from the nearest organizer service or contact the organizer.
 Your prompt treatment will be ensured.
- An Injury Investigation Protocol will be signed.
- Everyone is obliged to behave in such a way as not to cause a fire, to follow the safety rules and prohibitions related to fire security.
- Follow the instructions of the organizer service.

RULES FOR EXHIBITORS

- Opening hours for exhibitors are from 8:00 am to 6:00 pm. If the exhibitor stays for serious reasons after this time (e.g.: machine repair), notify the event organizer in person or by phone at the Těžební unie/Czech Republic Mining Association INFOCENTRE.
- Exhibitors must present their exhibitor card at the entrance.
- Every event day after leaving the fairgrounds, for security reasons, exhibitor must return the key to their EXPO stand at the Těžební unie/Czech Republic Mining Association INFOCENTRE.
- The speed of cars is limited to 30 km/h. They are only allowed to park in designated parking lots. From 9:00 am to 5:00 pm (opening hours for visitors), transport by private cars is not allowed.
- Due to the fact that the fair is held in a quarry and some exhibits will be in operation, it is necessary to
 follow safety instructions. All visitors and exhibitors are required to wear a safety helmet. It is especially
 important to take care of the safety of visitors.
- It is not allowed to ride a bicycle or any other mechanical or automatic mode of transport.
- It is not allowed to bring alcohol, narcotic and toxic substances, weapons and objects that may
 endanger safety. The organizer reserves the right to deny entry to the fair or eject the person who do
 not follow these safety regulations.
- It is not allowed to stay at the fair except the official opening hours, only during an official formal event at the invitation of the organizer.
- Exhibitors must report fire defects that they cannot remove by their own to the organizer. Objects and
 devices that can endanger the fire safety of people and property cannot be used. If the exhibitor wants
 to use an open fire at his exhibition (e.g. barbecue), he must notify the exhibition organizer and have a
 sufficient number of fire extinguishers or other fire protection needs.
- The revision of the electrical connection of all stands and exhibits must be inspected by a qualified worker. The exhibitor is also obliged to enable the revision of the electrical connection at every stands not ordered by the organizer.
